# CRAWFORD COUNTY ORDINANCE 2018 RAGBRAI

<u>Purpose</u>: To control safety and well-being of the public during the RAGBRAI visit to Crawford County on the  $22^{nd}$  and  $23^{rd}$  of July, 2018.

#### **Section 1, Definitions:**

 "Vendor" shall include any person, corporation, organization or other entity that sells food, beverages, services, or merchandise to the public by way of a temporary stand or distribution area in the unincorporated areas of Crawford County, Iowa, on July 22<sup>nd</sup> and/or July 23<sup>rd</sup>, 2018.

## Section 2, Violations:

- 1. The sale of food, beverages, services, or merchandise to the public by way of a temporary stand or distribution area in the unincorporated areas of Crawford County, Iowa, on July 22<sup>nd</sup> and/or July 23<sup>rd</sup>, 2018, is hereby declared to be in violation of this Ordinance.
- 2. It shall be a simple misdemeanor for any Vendor, as defined by this Ordinance, to operate within any unincorporated area of Crawford County, Iowa, on July 22, 2018 and/or July 23<sup>rd</sup>, 2018.

### **Section 3: Exceptions:**

1. The sale of food, beverages, services, or merchandise upon previously licensed premises, provided that the selling entity is otherwise in compliance with lowa Law and is in possession of all necessary permits and/or licenses, shall not be a violation of this ordinance.

#### Section 4, Conflict of Law:

1. During the applicable period of this Ordinance, such being July 22<sup>nd</sup> and July 23<sup>rd</sup>, 2018, this Ordinance shall take precedence over any existing Ordinance(s) or any portion(s) or provision(s) of any existing ordinance(s) which are or may be construed to be in conflict with this Ordinance. Following the applicable time period of this Ordinance, any and all such previous ordinance(s) or portion(s) or provision(s) thereof, shall remain in full force and effect.

#### Section 5, Severability:

1. If any section, part, or provision of this Ordinance should be adjudicated as unconstitutional or otherwise invalid, such adjudication shall not affect the validity of this Ordinance as a whole or the validity of any other section, part, or provision hereof.

# **Section 6, Applicable Period:**

- 1. This Ordinance shall become effective upon its final passage and approval by the Crawford County Board of Supervisors.
- 2. This Ordinance shall sunset and become ineffective at 12:01 A.M. on the 24<sup>th</sup> day of July, 2018.
